#### **REGULAR SESSION MINUTES**

June 10, 2019

### 1. Call to Order

Board Clerk Dean Craun called the meeting to order at 5:00 P.M. at the District's Fire Station, located at 14022 S Sunland Gin Rd., Arizona City, AZ.

# 2. Pledge of Allegiance

Board Clerk Dean Craun led all in the Pledge of Allegiance.

#### 3. Roll Call/Quorum

Board Clerk Dean Craun confirmed that all Board Members were present. A quorum was established with (4) members. Newly appointed Board Member Dewayne Hill also was in attendance.

1. comments or concerns regarding the 2019/2020 Annual Budget. No comments or concerns regarding the 2019/2020 Annual Budget were heard. Hearing no comments, Board Clerk Dean Craun closed the Public Hearing at 5:17 PM.

The Arizona City Fire District then entered back into Regular Session at 5:17 PM. Board Member Steve Ross made a motion to leave the Public Hearing and go into Regular Session; seconded by Board Member Dewayne Hill, motion passed unanimously.

Board Member Steve Ross made a motion to approve the final 2019/2020 Annual Budget; seconded by Board Member Randy Wittenburg, motion passed unanimously.

# 2. 2019 Annual Summer Safety/ Fire Prevention Program (Chief Jeffrey Heaton)

Fire Chief Jeffrey Heaton gave a recap regarding the Annual Summer Safety Program for 2019. We have been averaging around 110 children per day. Fire Chief Jeffrey Heaton stated that many donations have been received by the public to support the program and for the first time, the Arizona City Elementary School is providing lunches on Monday and Wednesday through the second week of June. This has been a great help.

## 3. 2019 Annual Arizona Fire School (Chief Jeffrey Heaton)

Fire Chief Jeffrey Heaton stated that this years' State Fire School is September 4-8. AZCFD B shift is not working during this time, so our 4 scholarships will go to B shift this year.
